

# ABOUT THIS PROGRAM

This program is designed for new members of existing Student Assistance Program (SAP) school teams. The training will provide new team members with the skills and knowledge necessary to become active members on an existing team. Training is developed based on Commonwealth approved competencies.

The Commonwealth of Pennsylvania's SAP, which is administered by the PA Department of Education's Safe Schools Office in partnership with the PA Department of Drug and Alcohol Programs' Division of Prevention and Intervention, and the PA Department of Human Services' Office of Mental Health and Substance Abuse Services, is designed to assist school personnel in identifying issues including alcohol, tobacco, other drugs, and mental health issues which pose a barrier to a student's success.

The primary goal of the Student Assistance Program (SAP) is to help students overcome these barriers in order that they may achieve, remain in school, and advance. While Student Assistance Programs exist in other areas of the country, the structure and operation of the program in Pennsylvania is a unique expression of an integrated model serving the needs of PA families and their students.
